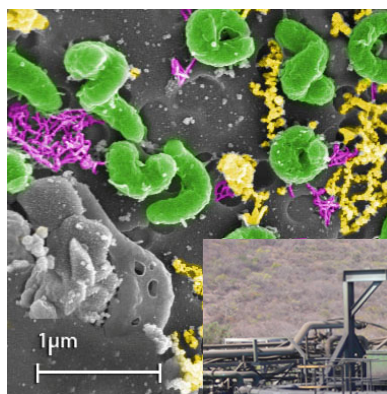
How can biotechnology help mining industry?

Biotechnology can be used in the minerals sector in a variety of ways, such as:

- Extraction of metals from low grade ores and wastes through bioleaching
- Liberation of valuable refractory metals through biooxidation
- Separation of minerals of interest from gangue minerals through bioflotation
- Biotechnical treatment and resource recovery from mine and process waters through biodegradation, biooxidation, bioreduction, bioprecipitation and biosorption
- Biostabilisation, bioremediation and ecological restoration
- Biological mineral formation
- Minerals exploration and element monitoring with biosensors

Moreover, understanding the role of microbes in biogeochemistry can help to mitigate microbially influenced problems such as:

- Acid mine drainage formation
- Biofouling, bioclogging and biocorrosion.

IBS 2022 Sponsorship Terms & Conditions

1. Applications must be received on the *Sponsorship Application Form – IBS 2022* (the “**Application Form**”).
2. On receipt of the signed Application Form, an invoice for the relevant Sponsorship Fee will be issued to the Sponsor by the Commonwealth Scientific and Industrial Research Organisation (“**Host**”).
3. Invoices are payable within 30 days from the date of invoice or 30 days prior to the Symposium start date, whichever occurs first.
4. All payments must be made in Australian dollars.
5. Sponsorship benefits will not be activated in the absence of a signed Application Form or full payment of invoice.
6. If full payment is not received by the due date, the Symposium organising committee (“**Organising Committee**”) have the right to review the sponsorship and reject the application.
7. The Organising Committee reserves the right, at its total discretion, to decline any sponsorship application.
8. Where a Sponsor wishes to cancel an Exhibition Booth booking, cancellations must be provided via email to the Chair of the Organising Committee anna.kaksonen@csiro.au. Where an Exhibition Booth cancellation is received at least 30 days prior to the start of the Symposium, 50% of any Sponsorship Fee received from the Sponsor will be reimbursed. If received within 30 days of the Symposium, refund will only be provided if the booth can be re-sold by the Symposium Organising Committee.
9. Sponsors agree to abide by any conditions laid down by the Organising Committee and agree not to violate any of the conditions of the Symposium venue. Sponsors will be responsible for any violation of the Symposium venue conditions by the Sponsor’s personnel, agents or contractors.
10. The Sponsor gives the Organising Committee permission to use the Sponsor’s name and logo in accordance with the details of the selected sponsorship package. Sponsors may not use the Symposium logo or the Host’s name or logo without the prior written consent of the Host.
11. Acknowledgement of Sponsors in the Symposium program is dependent upon the date the Sponsor’s application is received by anna.kaksonen@csiro.au, provision of the Sponsor’s logo and printing/publishing date of the program.
12. Details of all signage, collateral, advertisements and any other artwork to be displayed at the Symposium by any Sponsor must be provided to the Chair of the Organising Committee for approval at least one week before the Symposium start date. The Organising Committee reserves the right to reject anything that it considers inappropriate.
13. Exhibitors must not erect any sign, display or obstruction which intrudes into any adjoining Exhibitors’ space or affects the safety of the Symposium venue.
14. Sponsor must not damage in any way the walls, floors, ceilings or any other surface of the Symposium venue or the Sponsor will be liable for all associated charges due to the venue.
15. The Host and Organising Committee accept no responsibility whatsoever for any actions, suits, proceedings, claims, demands, costs and expenses, which may arise from the supply of promotional items, samples or other material by participating Sponsors to any person.
